|      | 2 | COMPLAINANT OUT TRICK OR TREATING FOR THE EVENING. PASSED A GROUP OF PEOPLE ONE OF WHOM PROCEEDED TO VERBALLY THEN PHYSICALLY ABUSE THE COMPLAINANT.   | NAMED SUSPECT EVID - VICTIM DOES NOT SUPPORT POLICE ACTION   |
|      | 3 | GROUP OF MALES KNOCKED ON DOOR PROFESSING TO BE TRICK OR TREATING. GRABBED BUCKET OF SWEETS AND WHEN CALLER PROTESTED ONE OF THE MALES PICKED UP A PUMPKIN FROM OUTSIDE THE FRONT OF THE HOUSE AND THREW IT AT A FRONT WINDOW SMASHING THE OUTER PANE. | NO SUSPECT IDENTIFIED - INVESTIGATION COMPLETE   |
